ASHI's Basic Life Support, BLS training course for Healthcare Providers and Professional Rescuers has been approved by American Safety And Health Institute (ASHI), accredited by Dubai Health Authority (DHA) & Ministry of Health (EHS).

#### WHO SHOULD ATTEND:

Individuals in the healthcare or professional rescuer field that are required to have completed a professional-level basic life support training course.

#### Required for Successful Completion (Certification):

Written Evaluation Required for all students as part of the basic life support course.

This certificate holds a minimum 3.5 CPD Points (Continuing Professional Development)

The objective of this qualification is to support a role in the workplace and is aimed at current or new staff who work in health and care settings (such as care homes, heath centres, surgeries and childcare settings) and give them underpinning knowledge of how to prevent and control the spread of infection.

The course is developed to support those who works in care homes, health centres, surgeries, childcare facilities, and day centres, understand the principles of effective infection prevention and control.
